**CAMP TUITION** - A deposit of \$500 is required to process each enrollment application. **Your final balance is due 10 days from the date indicated on your first invoice for the current camp season.** Accounts that are not paid in full by this date will forfeit all tuition discounts (sibling credits & early registration credits) and may be cancelled at the discretion of the camp. The camp tuition includes: board, lodging, camp nursing care (except lice treatments), program supplies (few exceptions), and activities (except "optional programs").

**SIBLING CREDIT** - Cayuga extends a discount to families who enroll 2 or more children. The tuition is credited \$400 for each additional sibling enrolled for the full-season and \$300, \$200, and \$100 for the 6-week session, half-session, and 2-week session respectively. The shorter session is used to determine the credit. There is no sibling credit for a stay less than 2 weeks.

**CANTEEN FUND** - The Canteen Fund is the only mandatory charge in addition to the camp tuition. The Canteen Fund charge is \$290 (full-season), \$200 (6-week session), \$160 (first & last half-session), \$120 (first & last 2-week mini session), \$90 (middle half-session), and \$60 (second & third 2-week mini-session). The Canteen Fund covers: one official Camp Cayuga T-shirt; Laundry Service; Snack Allowance (2 items - about \$2.00) for 5 days per week; off-season newsletters and other mailings. In addition, the Canteen charge includes admission fee & bus transportation to Amusement Parks as follows: Campers enrolled for the full-season attend two Amusement Park trips. Campers enrolled for 6-weeks; first & last half-session; first 2-weeks; and last 2-weeks attend one Amusement Park trip. There is no Amusement Park trip during the middle half-session, second 2-week & third 2-week mini-sessions. Since the total cost of the canteen items exceeds the amount charged, there is never a prorated refund of the Canteen Fund. Do not confuse the Canteen Fund with your camper's *Camp Bank*, which holds your child's "spending money" for personal expenditures and nominal day-trip fees.

**REFUND OF PAYMENTS - FOR FIRST TIME CAYUGA CAMPERS:** Campers enrolling for their first summer are extended Cayuga's *First-Time Camper Guarantee*, which provides a refund of the camp tuition for the days not attended by the camper due to an early departure. The parent must abide by the camp policies regarding early departure procedures for the *First-Time Camper Guarantee* to apply. Tuition refunds are based upon the actual session the camper attends camp. Example: If a camper enrolls for the full-season and departs camp at the end of the first-half session, the first-half session tuition is charged (not one-half of the full-season tuition).

**FOR RETURNING CAMPERS:** No tuition refund is granted when a returning camper departs camp with 14 days or less remaining in the camper's enrolled session. If a returning camper departs camp with 15 days or more remaining in the original enrolled session, the camp will refund one-half of the tuition balance after deducting the ordinary charges for the period the child remained in camp. Example #1: If a camper enrolls for the full-season and departs at the end of the first-half session, the charge is the first-half session tuition plus one-half the difference between the full-season tuition (original session) and the first-half tuition (new session). Example #2: If a camper enrolls in the first-half session (28 days) and departs on the 11<sup>th</sup> day, the charge is the first 2-week session tuition prorated for 11 days plus one-half the difference between the first-half tuition (original session) and the first 2-week tuition prorated for 11 days (new session). Example #3: If a camper enrolls in a 2-week session and departs before the end of the session, the charge remains the same. There is no refund when a returning camper departs camp with 14 days or less remaining in the camper's enrolled session.

**FOR ALL CAMPERS:** Refunds are mailed after the camp season but before September 30<sup>th</sup>. Tuition fees and refunds are based upon the actual session(s) the camper attends camp. Any discounts and/or credits relating to the actual session are applied. If a camper arrives late to camp, no tuition credit or canteen credit is given for the missed days. Cayuga reserves the unrestricted right to dismiss, without a refund, any camper who exhibits emotional, psychological or behavioral conditions that are disruptive to the camp program or that are harmful to himself or the well being of other campers or staff.

**CANCELLATIONS** - Cancellations received on or before April 30<sup>th</sup> incur a \$250 fee. Enrollments cancelled after April 30<sup>th</sup> incur a \$500 fee. All remaining payments will be refunded.

**CAMPER TREATMENT AUTHORIZATION & HEALTH INSURANCE** - Infirmary medical care is provided as part of the camp tuition (except for lice/nits treatments). Certain illnesses and/or injuries are referred by the Infirmary Staff to outside medical professionals whose fees are not covered by the camp's tuition or canteen fund. *If it is necessary, in the judgment of the Camp Director, to use outside medical, surgical, or dental aid for the camper's health, the parent(s) or legal guardian hereby authorizes him to obtain this medical care and further agrees to pay for the medical services provided, including any medical expense not covered by the parent's/legal guardian's health insurance policy. All campers are required to carry health insurance.*

**OPTIONAL LINEN RENTAL SERVICE** - This service includes sheets, pillowcases, and blankets. Pillows, towels, and washcloths are not included and need to be provided by the camper. The charge for this optional service is \$110 (full-season), \$80 (6-week session), \$55 (half-session), and \$30 (2-week session). There is no prorated refund for this service if a camper arrives late or departs early from camp. Note: The weekly laundering of all linens (and clothing) is included in the Canteen Fund.

**OPTIONAL BUS AND BAGGAGE SERVICE** - Camp Cayuga provides bus transportation and baggage service 4 times during the camp season: (1) on opening day; (2) from camp at the end of the first-half session; (3) to camp at the beginning of the second-half session; and (4) from camp at the end of the full season. This service caters to the areas of New York, New Jersey, Philadelphia, and Maryland. The charge for this optional service is \$180 round trip (or \$95 one-way), except for White Marsh, Maryland which is \$190 round trip (or \$100 one-way).

**OPTIONAL SPECIAL AIRPORT TRANSPORTATION SERVICE** - Cayuga provides transportation to/from 3 airports on the first & last day of each session. A Senior Staff Member will personally escort your child to/from the terminal gate. The roundtrip charge per child is \$120 (\$60 one-way) for Scranton Wilkesbarre Airport (Avoca, Pennsylvania), \$180 (\$90 one-way) for Newark International Airport (New Jersey), and \$210 (\$105 one-way) for JFK International Airport (Jamaica, New York). If the flight date is scheduled on any date other than an official camp session date, an extra fee will be added as follows: Newark Airport (extra \$30 one-way) and JFK Airport (extra \$50 one-way). We discourage JFK Airport for travel-time purposes. To request this service, complete the *Airport Transportation Service Request Form*. Before making your flight arrangements, read the *Airport Transportation Instructions*. After making your flight arrangements, complete the *Airport Transportation Itinerary Form*. These forms are accessible on Cayuga's website.

**OPTIONAL PROGRAMS: PRIVATE TENNIS LESSONS, ATV QUAD RIDING, PAINTBALL, SCUBA DIVING CLINIC, SURVIVAL CLINIC, and ACADEMIC TUTORING** - Optional Programs are not included in the tuition and require advance registration. Online registration forms, as well as paper forms (PDF), are available on Cayuga's website.

**CONDITIONS OF ENROLLMENT** - Camp Cayuga strives to provide positive camp experiences for children with various needs whenever possible. However, Camp Cayuga does not provide programs that are rehabilitative or therapeutic in nature, and does not specialize in serving children with special needs, including children with emotional, social, or behavioral difficulties. Please provide information (attach a separate sheet) regarding your child's special needs, including any disabilities, disorders or medical problems with this application form. It is important to determine if Camp Cayuga is appropriate for your child prior to attending camp. Failure to provide adequate information prior to your child attending camp may result in the camper being sent home without a refund. Cayuga cannot accept children who do not have the promise of living cooperatively with others.

I understand & certify that my child's participation in Camp Cayuga and its activities (on or off-camp) is completely voluntary and I have familiarized myself with the camp's program and activities in which my child will be participating. I recognize that certain hazards and dangers are inherent in the Camp's programs particularly, but not limited to: horseback riding, ATV quad riding, lake & pool swimming, ropes course, rock climbing, zip line, hiking on mountain trails, back packing, cabin overnights, canoe/tubing trips, circus acts, flying trapeze, tetherball, gymnastics, cycling on mountain trails & public roads, land & water sports, water slides, baseball, lacrosse, cheerleading, archery, riflery, athletic competition including bodily contact and contact with equipment and balls, intercamp games, inline skating, skateboarding, scuba diving, paintball, bungee trampoline jumping, use of power tools and equipment in certain creative arts activities, and travel in camp-owned and leased vehicles. I acknowledge that, although Camp Cayuga has taken safety measures to minimize the risk of injury to camp participants, the Camp cannot insure nor guarantee that the participants, equipment, premises and/or activities will be free of hazards, accidents or injuries. I recognize these risks and hereby assume these risks and agree to hold harmless and hereby release Camp Cayuga, its directors, owners, agents, and employees from all liability for loss, damage, injury or illness to the camper or camper's property related to his/her participation in the camp program. Furthermore, I have instructed my child in the importance of knowing and abiding by the camp's rules, regulations and procedures for the safety of all camp participants, and the requirement that campers must attend scheduled activities and remain supervised at all times, and my child has agreed to do so.

Camp Cayuga is not responsible for articles of clothing or personal belongings said to be lost or damaged by fire, theft or laundry.

I understand that cell phones are prohibited in camp and will be confiscated if brought to camp. They will be shipped C.O.D. with a \$50 handling charge.

I permit the use of any photos, video, slide, film, sketches or comments of my camper for commercial purposes.

I permit the camp to publish my camper's email address in the camp's Pen Pal Email Directory, unless otherwise indicated on the reverse side of this application.

Parental Travel Consent: If I register my child for the Canada Trip, I give Camp Cayuga permission to take my child across the United States/Canadian border in order to participate on the trip.

A 3% fee will be applied to all payments made by credit card. The camp accepts Visa & MasterCard.

A finance charge of 1.5% per month (18% annually) will be applied to all outstanding debts. Accounts which have not been paid, when the balance is due, will be subject to attorney fees (at least \$1500) and costs of the court and collection.

It is agreed that the venue and place of trial of any dispute or cause of action arising between the parties, whether out of this agreement or otherwise, shall be the Court of Common Pleas located in Wayne County, PA and shall be construed in accordance with the laws of Pennsylvania. If the Camp is successful in any litigation, it is agreed that the losing party will reimburse the Camp for all attorney fees and costs of litigation.

The parent hereby states that the camper is in good, normal health and has no abnormal physical or mental handicaps unless otherwise indicated on the attached sheet. The parent hereby states that the camper is of sufficient maturity to properly care for his/her hygiene & participate in the camp's program.
