All campers are eligible to participate in the ATV Riding activity subject to an evaluation of the camper's physical and mental maturity. There are no age restrictions. Cayuga's ATV riding program features child-size Suzuki 4-wheelers. This optional activity is not included in the camp tuition. The extra program fee is \$52 per 50-minute period. Advance registration is required.

SAFETY TEST: Campers are given a safety control test to determine their ability to manage the ATV and understand its operation. If the instructors determine your child can safely operate the ATV, he/she will be scheduled this activity. If your camper is evaluated as being unable to control the ATV, all remaining fees will be refunded. Quad riders must wear long pants and boots. The camp provides the safety equipment including helmet, goggles, and safety pads.

IMPORTANT: This activity takes place during the daily activity program, and is assigned by our program staff. Your child is required to attend when scheduled. If your camper does not attend, the activity will NOT be rescheduled and NO refund will be given. Please emphasize the importance of attendance to your child. Two exceptions: 1) This activity will be rescheduled if the camper is medically excused or the activity is cancelled (inclement weather); 2) A refund will be provided if the camper was never scheduled to attend.

<b>TO REGISTER:</b> Login to your account, go to 'Forms & Documents' on your dashboard, click 'Additional Options', then click 'Optional Programs' and select 'ATV Quad Riding'. This online feature will be turned-off within one week of your camper's arrival. At that time, you will need to complete this paper registration form. To return this form, please upload.

If a two-week camper registers for 4 ATV sessions, (2 weeks x 2 times = 4 max), no other optional activities are available. Note: Optional 'clinics' (scuba & survival) are treated differently and have no set limits.

## ATV RIDING ACTIVITY RELEASE FORM

## WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

In consideration of permitting my child to participate in the guad riding activity conducted at Camp Cayuga I, for myself and on behalf of my child, my personal representatives, heirs and next of kin do the following

I hereby acknowledge that quad riding is a potentially dangerous activity and involves the risk of serious injury and/or death and/or property damage. While particular protective equipment and personal discipline will minimize this risk, the risk of serious injury does exist.

I fully understand and acknowledge that: (a) risks and dangers exist in my child's operation of a guad. (b) my child's participation in such activities and/or use of a quad may result in injury or damage to personal property including the potential for permanent disability and death, (c) these risks and dangers may be caused by the quad activity operator, camp staff members or other participants, or by accidents, or by forces of nature or other causes. Risks and dangers may arise from foreseeable and unforeseeable causes including but not limited to, selection of quad track, trail or uneven terrain, weather conditions, and such other risks, hazards and dangers that are integral to recreational activities that take place in a wilderness, outdoor or recreational environment.

I understand that the activity of quad riding is physically and mentally intense. I have instructed my child in the importance of knowing and adhering by the rules, regulations and procedures established for the safety of quad riding participants and my child has agreed to do so.

I hereby release, waive and discharge Camp Cayuga, its owners, directors, officers, employees and agents (the

I hereby assume full responsibility for any risk of bodily injury, death or property damage, now and forever, arising out of or related to participation and/or instruction in said course, activities, or any related quad riding operation, whether foreseen or unforeseen and whether caused by the negligence of the Releasees or otherwise. I hereby separately agree to indemnify and save and hold harmless the Releasees from any loss, liability, damage or cost that they are incur, now and forever, arising out of or related to my child's participation and/or instruction in said course, activities, or any other related guad riding operations, whether caused by the negligence of the Releasees or otherwise.

I hereby acknowledge that this Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement extends all acts of negligence by Releasees, and is intended to be as broad and inclusive as permitted by the laws of innsylvania and that if any portion thereof is held valid, it is agreed that the balance shall notwithstanding, continue in full legal force and effect.
